For nearly 15 years, my passion and priority has been to provide a very professional and comprehensive style of medical care. Changes in the healthcare system, including costs that are outpacing insurance reimbursement, have unfortunately made it near impossible to maintain my family practice. Rather than compromise on the quality of medicine, I have decided, as have other small primary care practices, to enlist the support of my patients to help keep their care personal, accessible and affordable.

Starting March 1, 2018, I will begin to limit the total number of patients enrolled in my practice and enhance our current level of personalized care for an annual membership fee of \$400 per patient with no additional fee for dependents 26 and under. While I regret the need to impose an additional expense on my patients, I would otherwise be unable to continue offering the benefits you have come to expect during a visit to my office; more time spent with you, same day/next day appointments, comprehensive wellness consultations and most importantly, someone who knows you and your needs on a personal level. As a member, you will also be given a 10% discount on services and products in the office and the ability to contact one of our providers through a variety of media.

Also be aware that your membership fee is **NOT** reimbursable through your insurance, **the cost is totally out of pocket**. If you do not wish to continue care with us, we will be sorry to see our relationship end but certainly understand. I will be happy to refer you to other primary care resources if needed and will forward your medical records without charge to your new provider upon receipt of signed medical records release; in the meantime I will be happy to continue your care for up to 3 months.
